9/17/71 - MI&RU Aztec Well Service Unit. Pulled rods.

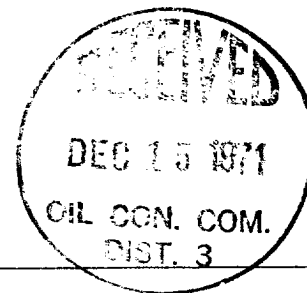
Spotted cement plug from 5306' to 5206'. Pulled 2" tubing.

Worked 5 1/2" casing to free same. Rigged up Blue Jet, perforated from 1669' to 1670' w/4 shots. Ran 2" tubing. Spotted cement plug from 1670' to 1520'. Pulled 2" tubing. Shot off casing at 910'. Spotted cement plug from 960' to 825', 50' inside casing stub and 35' above 5 1/2" casing stub.

Pulled total 22 joints 917' of 5 1/2" OD casing.

Spotted 10' cement plug in surface casing. Installed dry hole marker.

Completed P&A 9/17/71.

Gentlemen:

Form C-103, Notice of Intention to Plug, your East Unit Unit 65 H 22 24 100
Lease Well No. Unit- S-T-R
was approved on 8-25-71. Your subsequent notice of plugging cannot be
approved until a commission representative has made an inspection of the location
to see:

- (1) all pits have been filled and leveled;
- (2) a steel marker, 4" in diameter and approximately 4' above mean ground level, must be set in concrete, this marker must have the quarter-quarter section or unit designation, section, township and range numbers, which shall be permanently stenciled or welded on the marker;
- (3) the location shall be cleared and cleaned of all junk;
- (4) the dead man wires must be cut.

The above are the minimum requirements.
