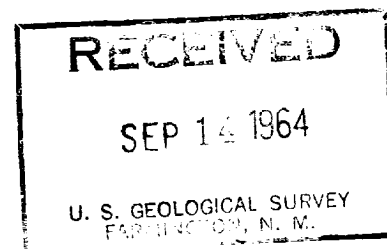

Consolidated Oil & Gas proposes to plug and abandon the Huerfano Federal # 2-31 as follows. Spot a cement plug from 6300 to Total Depth with cement into the perforations. A 100' cement plug will be placed at the stub of the pipe with mud between all plugs. A cement plug will be placed at 2650' to 2750' to isolate the Pictured Cliffs and Mesaverde and a cement plug from 1150' to 1300' to isolate Ojo Alamo. A surface plug will be placed in the top 100' and a permanent marker erected. All pits will be leveled and the location cleaned of all junk.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
