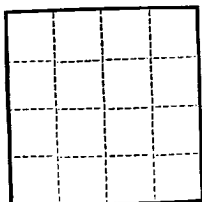

It is our intention to drill well No. 1 to approximately 5500' to test the Gallup formation. Our casing program is as follows:

300' of 10-3/4" OD casing, cemented with 200 sks. of regular cement - circulated.
5500' of 5-1/2" OD casing, cemented with 250 sks. of regular cement.

The designated drilling unit is the NE/4 NE/4 of Section 31-25N-10W, San Juan County, New Mexico.
