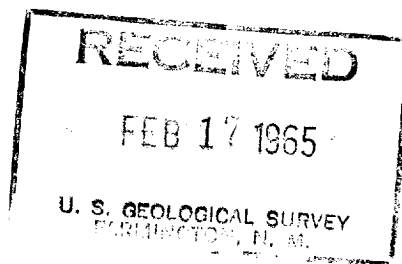
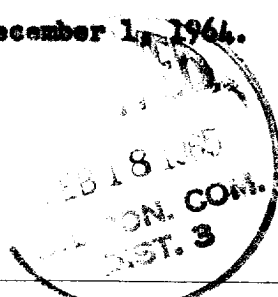

Moved in and rigged up pulling unit. Killed well with 75 bbls. of water. Pulled 2" tubing. Ran sand pump and found well clean. Ran 2" tubing and set packer at 5101'. Installed Water Injection Equipment and started injecting water into the Gallup Formation through 5-1/2" OD casing perfs. 5144-5195' on FEB 13 1965.

This well is a Water Injection Well for the East Bisti Unit.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
