250' of 10-3/4" OD casing, 32.75# H-40, cemented with 250 sks. reg. cement, to be circulated.

5500' of 5-1/2" OD casing, 11# J-55, cemented with 250 sks. cement.

The designated drilling unit is the SE 1/4 - NE 1/4 of Section 28, San Juan County, New Mexico.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

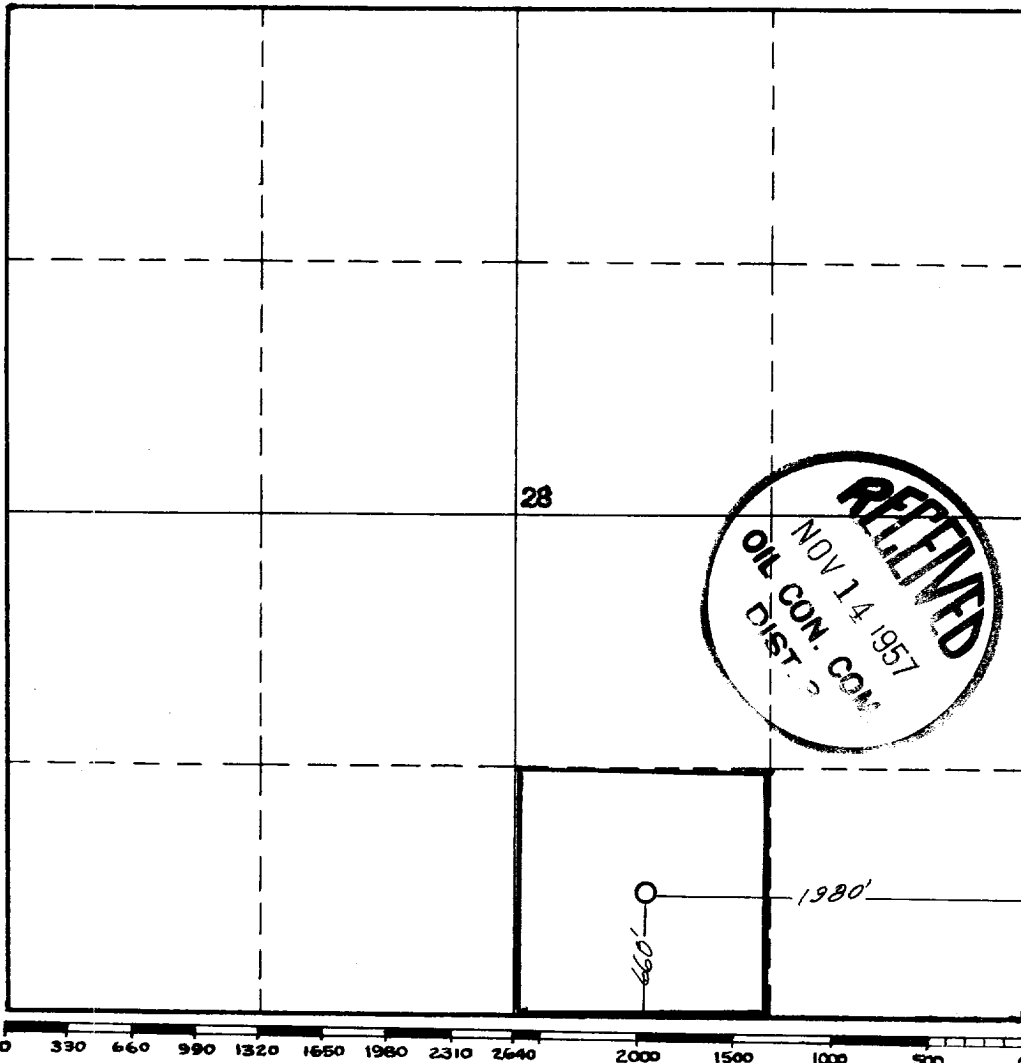
