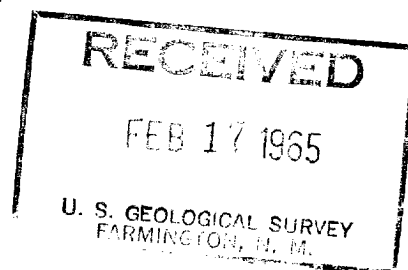
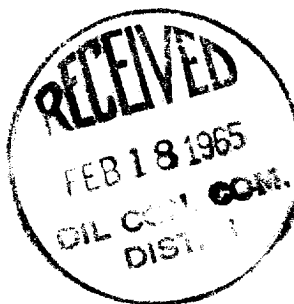

Moved in and rigged up pulling unit. Pulled rods and 2" tubing. Ran sand pump and cleaned well out from 5211' to 5219'. Ran 2" tubing and set packer at 5119'. Installed Water Injection Equipment and started injecting water into the Gallup Formation through 5-1/2" OD casing perfs. 5176-5209' on FEB 13 1965.

This well is a Water Injection Well for the East Bisti Unit.

Instructions
