It is our intention to drill Well No. 6 to approximately 5500' to test the Gallup formation. Our casing program is as follows:

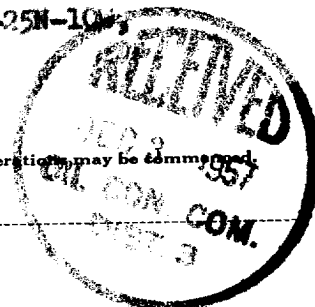
250' of 10-3/4" OD casing, 32.75# H-40, cemented with 250 sks. rog. cement, to be circulated.

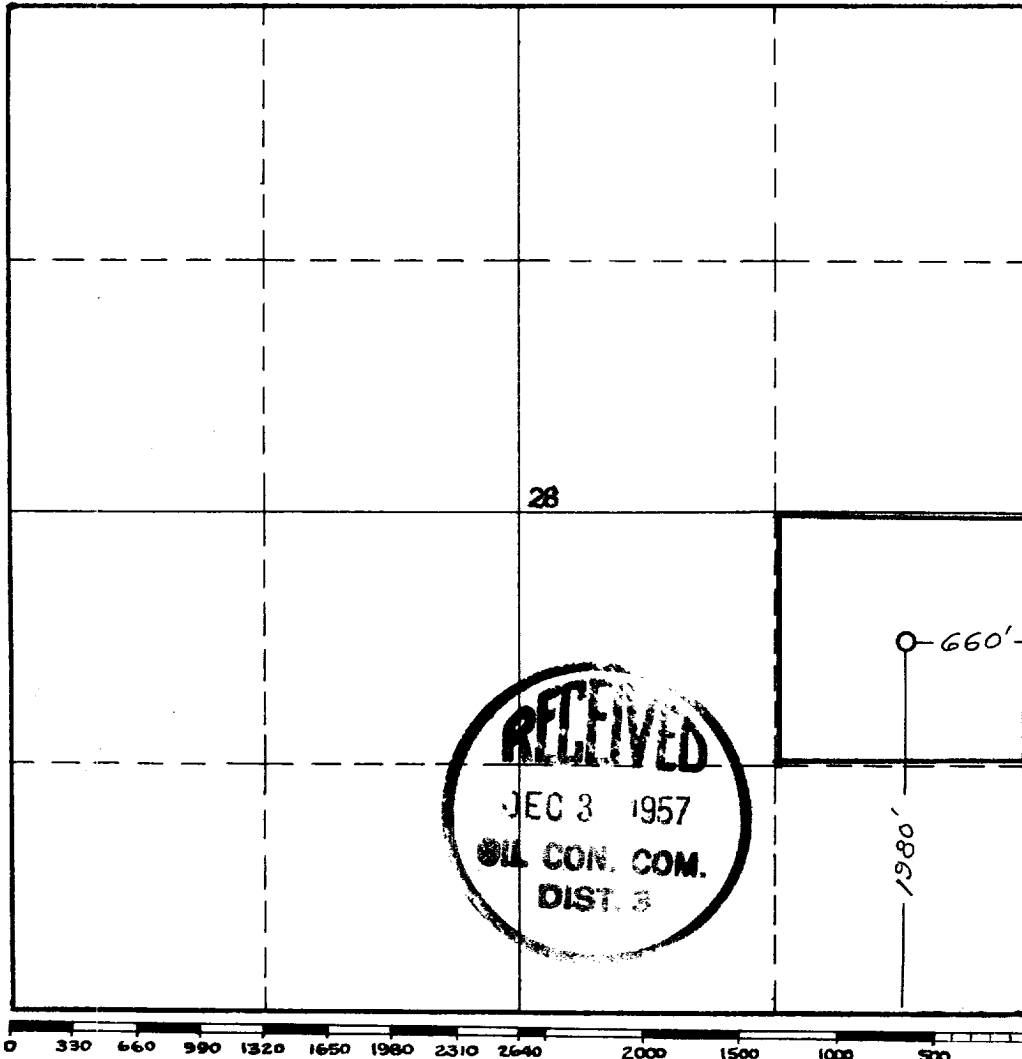
