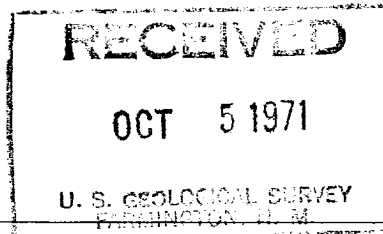
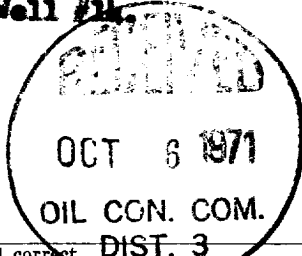

Effective 7:00 a.m., November 1, 1971, the East Bisti Gallup Unit is to be terminated. Skelly Oil Company is Operator of the Unit. With the termination of the Unit, the various properties comprising the Unit will be returned to the former Operators (Owners). Therefore, the subject lease will be returned to Atlantic Richfield Company and Sun Oil Company, with Atlantic Richfield Company being the Operator.

Unit battery facilities serving this well and lease are located in the NW SE (Unit Letter "J") Section 23-25N-11W. To eliminate the expense of relocating the battery and flow lines to the lease from which the oil is produced, it is proposed to utilize a portion of the current facilities for storage and pipe line runs. This will be separate storage and production will not be commingled with production from any other lease. Battery facilities are located on the former Mar-Ga-Le-To Lease, Contract No. 14-20-603-1381, also Atlantic & Sun.

Current designation is Unit Well #14.
