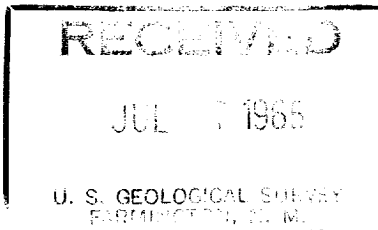

Reason for workover was to stimulate oil production.

Commenced workover on 6-2-65. Treated perforations 5012- to 5018' and 5026' to 5040' with 20 barrels of regular 15% acid. Perforations 5012' to 5018' treated at 500 psi and perforations 5026' to 5040' treated at 300 psi. Flushed tubing with 35 barrels of lease crude oil. Swabbed 32 barrels of oil in four hours. On 24 hour test ending 10:00 AM, 6-28-65, well pumped 6 barrels of 41.4° gravity oil and 6/10 barrels of water. Length of pump stroke 32" with 9 strokes per minute.

Instructions
