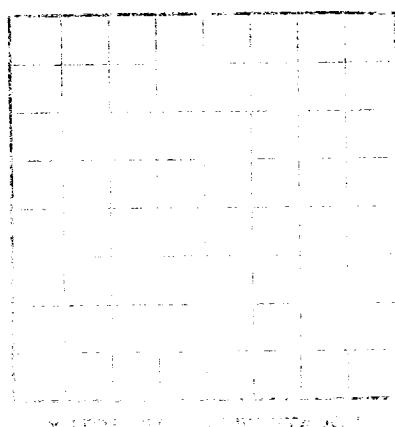

After drilling to 5079, and cementing 5-1/2 casing, top of cement was found at 5052 (BBL). Perforated 5-1/2 casing 4975 to 4957, and 4966 to 4978, with 4 jets per foot. Gas tubing to 4962 and treated with 500 gallons mud acid. While swimming, well commenced to flow.

It is of the greatest importance to have a complete history of the well. Please state in detail the dates of redrilling, together with the reasons for the work and its results. If there were any changes made in the casing, state fully, and if any casing was "sideracked" or left in the well, give its size and location. If the well has been dynamited, give date, size, position, and number of shots. If plugs or bridges were put in to test for water, state kind of material used, position, and results of pumping or bailing.
