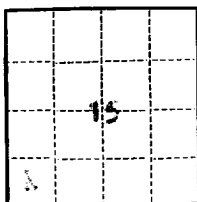

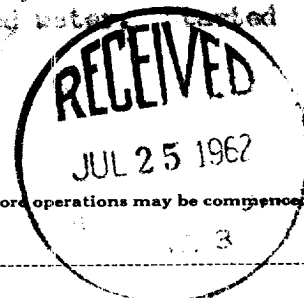
The elevation of the derrick floor above sea level is 6250.79 ft.

DETAILS OF WORK

Conversion work.

1. Pressure tested tubing with 1000 psi for 15 minutes, O.K.
2. Washed while running clean joint lookout water (treated with Triton 2-100 detergent) down casing. After tubing became clean, pulled. Pulled clean.
3. Run tubing with packer.
4. Started to bleed off inhibited water down casing to displace uninhibited fluid. Set packer at 3020', and filled with inhibited water. Started injecting water 6-22-62 at 2.5 l/b rate.
