Blew gas 45 min. - blew down. Pump 75 bbls to role hole. Pressure test to 500 PSI - blew down to 450 PSI. Spot 27 sx cement @ 3-1/2 BPM w/200-350 PSI. Displace w/17-3/4 bbls. TOH 53-jts. TIH 43-1/2 jts - tag cement @ 4564', 6-1/2 joints out. TOH - lay down 88-jts. RIH w/wireline - perf 3 shots @ 2047'. POH. TIH w/5-1/2 retainer set @ 1990'. Pressure test to 500 PSI - held okay. Est rate 1.1 BPM @ 1200 PSI. Spot 48 sx outside & inside casing, 1-1/4 BPM @ 500-1200 PSI. Displace w/5-1/2 bbls. TOH -lay down. TIH w/wireline - perf 3 shots @ 1284'. POH. TIH w/5-1/2 retainer set @ 1232'. Est rate 1-1/2 BPM @ 700 PSI. Spot 48 sx cement. Displace 2.4 bbls. TOH. RIH w/wireline - perf 3 shots @ 975. POH. TIH w/5-1/2 retainer set @ 916'. Est rate 1/2 BPM @ 900 PSI. Spot 48 sx cement, 2-1/2 BPM @ 400 PSI. Displace w/27.3 bbls. Circulate 130 bbls cement to surface. ND BOP.
