Circulate hole clean. P/U 4-1/2 CBIP set @ 4774'. Pressure test casing. Spot 12 sx cement. Pullout. Perforate squeeze holes @ 2096'. Spot 51 sx cement inside and outside casing. Perforate squeeze holes @ 1271'. Spot 51 sx cement inside and outside casing. Shoot squeeze @ 901'. Spot 51 sx cement inside and outside casing. Shoot squeeze holes @ 156'. Spot 50 sx cement inside and outside casing. Circulate cement to surface Cut off wellhead. Install dry hole markers. Restore location.
