13. Describe Proposed or Completed Operations (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Elm Ridge Resources Inc proposes to plug and abandon the Carson Unit 17 #113 in accordance with regulations. Production equipment will be removed from the well and tubing will be used to pump plugs. Perforate and squeeze will be used unless casing can be recovered over the specified. Proposed procedure: Notify BLM office 24-hours prior to commencement of work. Sting back into packer @ 5600'. Pump enough cement to cover the Dakota + 50% excess top of 5730'. Sting out of packer. Set a cement plug from 5500' to 5600'. Set a CIBP @ 4810'. Spot a cement plug from 4760' to 4810'. Set a 100' cement plug across the top of the Mesa Verde from 1954' to 2054' inside and outside of 5-1/2 casing top @ 2004'. Set a 100' cement plug across the top of the PC/FC from 1140' to 1340' inside and outside of 5-1/2 casing. Set a cement plug from 360' to surface across top of Ojo Alamo top @ 310'. Cut off wellhead. Install dry hole marker. Clear and remediate location.
