RIH to 4775' - circulate hole clean. P/U 4-1/2 CIBP - run in set @ 4775'. Pressure test casing. Spot 12 sx 14.16 cubic ft cement - pull out. Perforate squeeze holes. Spot 51 sx inside and outside casing @ 2073'. Perforate squeeze holes @ 1202'. Spot 51 sx inside and outside casing @ 897'. Perforate squeeze holes @ 75'. Spot 50 sx - circulate cement to surface. Cut off wellhead. Install dry hole markers. Restore location.
