Dear Mr. Fellows:

Reference is made to your letter dated August 15, 1988 concerning Hixon Development Company's plans for eight wells located in the Carson Unit. The Carson Unit Well No. 34-18 is currently awaiting approval from the New Mexico Oil Conservation Division and the Bureau of Land Management to be used as a gas storage well. Upon final approval for this project, work will be commenced to convert the well to a gas storage well.

Hixon Development Company plans to return the Carson Unit Well No. 34-19 to production. A Sundry Notice of intent to return the well to production will be forthcoming.

The remaining six wells addressed in your letter are currently being reviewed as part of an in-depth Carson Unit waterflood and production study. Included in the study are future plans to return additional wells to production and injection as the price of oil increases. With 4.8 million barrels of remaining recoverable oil in the Carson Unit it is important that all existing wellbores be kept available for use as injection and/or producing wells for future waterflooding and enhanced recovery operations.

In addition to the waterflood study, we are also initiating a study of the Fruitland Coal in the Unit. This study is the first step in evaluating the Unit's untapped coal gas potential. The study will be followed by testing of the Fruitland Coal using existing wellbores in the Unit.
