Elm Ridge Resources Inc. proposes to plug and abandon the Carson Unit 13 #33 as follows: MIRU. Pull out and laydown production equipment. P/U 4-1/2" scrapper with work string. RIH to 4780'. Circulate hole clean. P/U 4-1/2" CIBP - set @ 4780'. Pressure test casing. Spot 12 sx cement - pullout. Perforate squeeze holes @ 2052'. Spot 51 sx cement inside and outside casing. Perforate squeeze holes @ 1203'. Spot 51 sx cement inside and outside casing. Perforate squeeze holes @ 893'. Spot 51 sx cement. Perforate squeeze holes @ 154'. Spot 50 sx cement. Circulate cement to surface. Cut off wellhead. Install dry holes markers. Restore location.
