Spotted cement plug from 1315' to 1165' and from 450' to 350'. Pulled tubing

Spotted 10' cement plug in surface casing. Installed dry hole marker.

Completed P&A 8-10-71.

Casing was collapsed. Did not attempt to pull casing.
