Elm Ridge Resources, Inc, plugged the well in accordance with regulations. Production equipment was removed and the well was plugged as follows:

TIH with rods and tubing - got stuck in liner - worked tubing up and down, turned to right and tubing came loose. Nipple up BOP. TOOH w/production string. TIH w/tool to fish out liner. Catch onto top of packer. TOOH w/fishing tool. TIH w/scrapper. TOOH w/scrapper. TIH w/tubing to 4712' to spot plug. Est circ 17 bbl to circulate fluid. Spot cement. TOOH to liner top - tag cement @ 4420'. TOOH w/2-1/16 tubing laying down. TIH w/wireline, perf @ 2001'. TIH w/2-3/8 tubing to 1984' w/retainer. Est circ 13 bbl to load, est rate - could not pump into formation @ 100 PSI. Spot 12 sx cement on top of retainer. TOOH w/stinger. TIH w/wireline, perf @ 1254 - set retainer @ 1209'. Pump 50 sx cement. TOOH w/stinger. TIH w/wireline, perf. @ 927'. TIH w/retainer to 877'. Establish rate 2 bpm @ 900 PSI. Spot 50 sx cement. TOOH w/stinger. TIH w/wireline, perf @ 300'. Est. rate 2-1/2 bpm @ 400 PSI. Pump 150 sx cement and circulate to surface. Plugging complete.
