D. Pictured Cliffs from 1290' to 1190' using 45 sacks cement, inside and outside casing.

E. Place Fruitland plug from 954' to 854' using 51 sacks cement, inside and outside casing.

F. Surface plug from 330' to surface to cover the Ojo Alamo inside and outside the 4 1/2" casing using 180 sacks c
