Central Resources, Inc. plans to plug and abandon the subject well as follows:

- 1) Plug will be set from the bottom perforation (1230') to the surface (112.2 cuft) by mixing and pumping 102 sks (117.3 cuft) of Class B neat cement.
- 2) After cement has set up, tag top and refill hole, if necessary.
- 3) Run 1" pipe down casing annulus to 260' and fill annulus with 56 sks (64.4 cuft) cement.
- 4) Cut off wellhead and install a regulation dry hole marker.
- 5) Rehabilitate location as per BLM regulations.
