Elm Ridge Resources, Inc, plugged the well in accordance with regulations. Production equipment was removed and the well was plugged.

RIH w/CIBP and 150-joints set @ 4645'. Pump 10 sx Class "B" cement above CIBP. TOC @ 4575'. POOH w/27-joints to 3800'. Pumped balance plug 100' +50% excess. 150' plug to 3750' - 12 sx Class "B" cement. POOH w/tbg. RIH w/wireline, perf. @1909'. WOC RIH w/wireline tag top of cement @ 3666'. RIH w/cement retainer set @ 1854'. Started pumping cement through retainer - got circ. @ surface pumped 51 sx Class "B" cement. POOH w/24-joints to 1172' reverse circ. to clean hole - tag cement @ 1429'. We figured there was hole in casing @ 900'. Decided w/BLM to set retainer @ 803' FS and circ. cement to surface. Pumped 340 sx Class "B" cement never got cement to surface. RIH w/tubing - tag cement @ 752' - pump Class "B" cement down 4-1/2 csg to surface w/ 57 sx cement. POOH w/tubing - tie into bradenhead - pump 82 sx Class "B" cement down bradenhead. Enough to cover 210' +50% excess pumped 1/4 bbl minute @ 500 to 1000 PSI.
