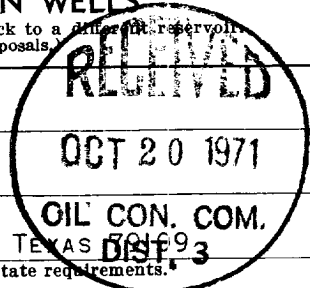

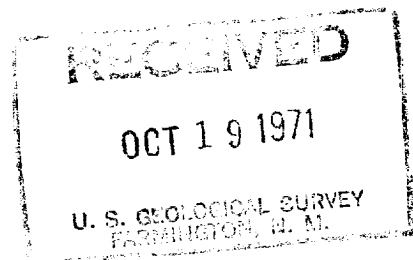
THIS WELL WAS FLOW TESTED THROUGH A PORTABLE TESTOR FROM THE PERIOD SEPTEMBER 1 THROUGH SEPTEMBER 14. THIS TEST RESULTED IN AN ESTABLISHED RATE OF 4.2BOPD, 0BWP, GAS TSTM, ON VARIOUS CHOKES.

THE PURPOSE OF THE TEST WAS TO ESTABLISH FEASIBILITY OF INSTALLING PUMPING EQUIPMENT ON THIS WELL.

THIS REPORT CONSTITUTES NOTICE OF ALTERING THE PRODUCTIVE CAPABILITIES OF THIS WELL AND ACCORDINGLY OF THE CENTRAL BISTI UNIT.

IT IS ESTIMATED THAT THIS WELL WILL PRODUCE 120 BOPM.

PUMPING EQUIPMENT WILL NOT BE INSTALLED ON THE WELL BUT IT WILL BE INTERMITTENTLY FLOWED AND WILL BE REPORTED WHEN ON FLOWING STATUS.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
