- 1. Run tubing to bottom, pressure up annulus and tubing to 300 psi and cement with 20 sacks.**
- 2. Pull tubing to 60' and cement with 10 sacks and install abandonment marked with "Shell Oil Company, Carson Unit 14-11, SW/4 SW/4 Section 11, T. 25 N., R. 12 W., N.M.P.M."**

Reason for abandonment, production rate will not justify repair work.

Instructions
