RIH w/-5/12 CIBP on wireline set @ 4750'. Circulate hole clean. Spot 27 sx cement, 5.7 bbl. POOH - wait 3 hours. RI - tag cement @ 4591'. Perf. squeeze 3 holes @ 1951'. Set retainer @ 1901'. Pump 29 sx cement outside and 17 sx cement inside casing. Total 46 sx cement - tag cement @ 1776'. Perf. squeeze 3 holes @ 1206'. Set retainer @ 1156'. Pump 29 sx cement outside and 17 sx cement inside casing. Perf. squeeze 3 holes @ 850'. Set retainer @ 795'. Pump 47 sx cement outside and inside casing. Perf. squeeze 3 holes @ 273'. Pump 117 sx cement. Circulate cement to surface. Plugging complete
