13 Describe Proposed or Completed Operations (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Elm Ridge Resources, Inc proposes to plug and abandon the CBU WI #14 in accordance with regulations. Production equipment will be removed from the well and tubing will be used to pump plugs. Perforate and squeeze will be used unless casing can be recovered over the specified. Proposed procedure: Notify BLM 24-hours prior to commencement to cementing. Pull all retrievable production equipment. Set a CIBP @ 4600'. Top of Gallup @ 4622'. Spot cement on top to 4550'. Spot a 1200' cement plug across the Mesa Verde from 1828' to 1928 inside and outside of 5-1/2 casing. Spot a 200' cement plug across PC/FC from 1010' to 1210' inside and outside 5-1/2 casing. Spot cement from 400' to surface inside and outside of 5-1/2 casing. Ojo Alamo top @ 350'. Cut off wellhead. Install dry hole markers. Clear and remediate location.
