Circulate hole clean. P/U 5-1/2" CIBP set @ 4652'. Pressure test casing. Spot 12 sx cement. Pullout. Perforate squeeze holes @ 1978'. Spot 48 sx cement inside and outside casing. Perforate squeeze holes @ 1100'. Spot 48 sx cement inside and outside casing. Perforate squeeze holes @ 790'. Spot 48 sx cement inside and outside casing. Perforate squeeze holes @ 278'. Spot 90 sx cement. Circulate cement to surface. Cut off wellhead. Install dry hole markers. Restore location.
