Elm Ridge Resources Inc. plugged the CBU #16 as follows: MIRU cementers est. circulation - pump 12 sx Class "B" cement w/ 2% CaCl2 on top of CIBP. Calculate top of cement @ 4560'. POOH w/tubing to 2000', circulate hole clean. Run bond log from surface to 1984'. Good cement @ surface and over Pictured Cliffs formation. POOH w/wireline. RIH w/perf. gun - perf. @ 1919'. Set retainer @ 1884'. Pump 51sx Class "B" cement inside and outside casing. POOH w/tubing. RIH w/wireline - tag cement @ 1250'. Perf. @ 1150' - cement behind casing @ 1172'. RIH w/retainer set @ 1112'. Pump 51 sx Class "B" cement inside and outside of casing. POOH w/tubing. RIH w/wireline perf @ 844'. Tried to pump down casing - pressure up to 1000 PSI - would not take any fluid. Decided to pump inside plugs. Pump 12 sx Class "B" cement - balanced plug @ 844'. POOH w/tubing to 155'. Pump 12 sx Class "B" cement to surface. Plugging complete. Witnessed by Marco K. w/ BLM Farmington Office
