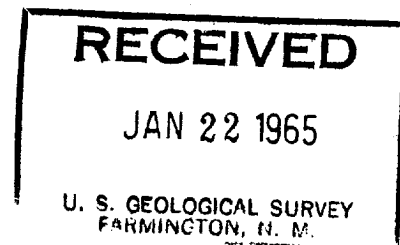

Leak occurred in casing - detected when mud and water entered casing. Ran Corrosion Log. Casing was in good shape except for severe pits at 2909' and 3109'. Set retrievable bridge plug at 3165'. Set retrievable retainer at 2800' and cemented through holes w/200 sacks class C w/3% Ca.Cl. and 85 sacks Halad 9 w/3% Na.Cl. cement. Drilled out cement and tested casing to 1000 psi, retrieved bridge plug and put back on production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
