- B. Set Menefee plug from 1907' to 1807' inside and outside casing using 51 sacks cement
- C. Set Pictured Cliffs plug from 1170' to 1070' inside and outside casing using 45 sacks cement
- D. Place the Fruitland plug from 812' to 712' inside and outside casing using 45 sacks cement
- E. Place surface plug @ 187' across the surface casing shoe @ 137' using 165 sacks cement
- F. Cut well head, install dry marker. Clear and remediate location.
