



DETAILS OF WORK

Drilled to total depth of 5000' KB, ran Logs, no shown in samples nor on Electric Logs. It is proposed to plug and abandon as dry hole by filling with heavy rotary mud with a 60 sax cement plug opposite the Gallup Sandstone, 45 sax cement plug opposite the Unacra formation, 45 sax cement plug opposite the pictured Cliffs formation, 20 sax cement in bottom of surface casing, erect dry hole marker, level and abandon location.
