FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

The subject well will be plugged in the following manner:

1. 100' cement plug across perforations
2. 50' cement plug below Mesa Verde inside the portion of casing that has cement on the outside
3. If casing can not be cut off below a point 100' above top of Mesa Verde, perforate and spot cement across top of Mesa Verde and have cement plug in casing
4. If casing can be cut off below a point 100' above top of Mesa Verde, set 50' cement plug across pipe stub and 100' cement plug across top of Mesa Verde
5. 100' cement plug across coal section of Fruitland on top of Pictured Cliffs and top of Pictured Cliffs
6. Cement plug at surface with dry hole marker
