- B. Cover top of the Mesa Verde from 2445' to 2345 using 47 sacks cement, inside and outside casing.
- C. Cover top of the Chacra from 1540' to 1440' using 30 sacks cement, inside and outside casing.
- D. Cover top of the Pictured Cliffs from 1167' to 769' using 24 sacks cement.
- F. Circulate 175 sacks of cement from 520' to surface leaving both inside and outside of casing full of cement.
