Central Resources, Inc. intends to plug the well in accordance with regulations. Production equipment will be removed well will be plugged as specified. Perforate and squeeze will be used unless casing can be recovered over the specified interval or there is evidence cement is in place behind the casing.

Proposed procedure:

- Notify the Farmington BLM office at 505-599-8907 24 hours prior to commencement of plugging operations.
- Pull all retrievable downhole production equipment.
- Set a CIBP at 4750' and spot 50' of cement on top.
- Set a 100' cement plug from 2014' to 22114' across Menefee top at 2064'.
- Set a 100' cement plug from 1172' to 1272' across the Pictured Cliffs at 1222'.
- Set a 100' cement plug from 782' to 882' across the Fruitland Coal at 832'.
- Set a 100' cement plug from 61' to 161' across the surface casing at 111'.
- Set a 50' cement plug from surface to 50'.
- Cut wellhead and install dry hole marker. Clear and remediate location.

Please take into account the number of existing P&A procedures, the number of P&A procedures you have requested available equipment and allow Central Resources, Inc. until the end of 2001 to complete this abandonment.
