- 1) Plug will be set from the bottom perforation (1155') to the surface (37.5 cuft) by mixing and pumping 34 sks (39.1 cuft) of Class B neat cement.
- 2) After cement has set up, tag top and refill hole, if necessary.
- 3) Cut off wellhead and install a regulation dry hole marker.
- 4) Rehabilitate location as per BLM regulations.
