Elm Ridge Resources plugged and abandoned the Central Bisti Unit #86 on October 15, 2001 as follows: MIRU Triple P Rig #6. TOH and laydown rods and tubing. Pick up and tally tubing. Run 5-1/2 scrapper to 4819'. TOH laydown scrapper. Pick up 5-1/2, CIBP set @ 4790'. Pressure test to 500 PSI for 15 minutes - held okay. Spot 31 sx cement from 4791'. Flush casing with 40 bbls H2O. Spot balanced cement plug @ 2002' with 18 sx cement. Spot balanced cement plug @ 1251' with 18 sx cement. Shot squeeze hole @ 970'. TIH and set 5-1/2 cement retainer @ 920'. Pump 50 sx cement. Shot squeeze holes @ 270', pump 95 sx cement and circulate to surface. Plugging complete.
