Elm Ridge Resources, Inc proposes to plug and abandon the Ananya Hixon #2 in accordance with regulations. Production equipment will be removed from the well and tubing will be used to pump plugs. Perforate and squeeze will be used unless casing can be recovered over the specified interval. Proposed procedure: Notify BLM office 24-hours prior to commencement of plugging procedure. Set a CIBP @ 4743'. Spot a 50' cement plug on top of CIBP. Set a 100' cement plug from 1917' to 2017' across Mesa Verde top @ 1967'. Set a 200' cement plug from 1100' to 1300' across top of PC/FC top @ 1193' FC and 1244' PC. Set a 365' cement plug from surface to 365' across top of Ojo Alamo top @ 340'. Cut off wellhead. Install dryhole markers. Clean and remediate well location.
