Elm Ridge Resources, Inc proposes to plugback the Alamo Wash 32 #34 in accordance with regulations as specified. Cement was circulated to surface in 1990. We will notify the BLM office 24-hours prior to commencement of plugback procedures. Lay down all production equipment. Set a CIBP @ 4800'. Spot cement on top to 4750'. Set a 250' cement plug across the Mesa Verde from 1909' to 2159' inside of casing. Pressure test to 1000# - if cement holds - shut well in until pipeline right of way can be obtained. We will complete in the Fruitland Zone.
