DETAILS OF WORK

After drilling to ~~17~~ 7420' it has been concluded this well will not be productive from formations below the Pictured Cliffs Sands. It is therefore proposed:

To spot cement plug in interval 7420' - 6990' with 70 sacks 50-50 pozmix with 4% gel - in two stages - 35 sacks per stage, and to spot a plug at interval 2760' - 2860' using 50 sacks cement, 2% CaCl.

To set 4-1/2" 9.5# casing at 2760' - cemented with 100 sacks cement.

To complete as Pictured Cliffs well - setting 1-1/2" tubing at 2645' for production.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
