Cleanout fill. Set 7" CIBP above perfs at 3007'. Ran 72 joints, 4-1/2", 11.6#, K-55, LT&C casing inside 7" casing and land at 3007'. Pumped 350 sacks POZ with 2% gel and 2% Ca Cl₂. Circulate cement to surface. Cut off 4-1/2" casing and changed out wellhead. Drilled out float collar and shoe. Pressure tested to 1500 psi. Held okay. Drilled out 7" CIBP and pushed to PBTD. Trip in hole with 2-3/8", 4.7#, J-55, 8rd, EUE tubing and land at 3043'. Swab well in.
