1. Set Baker Drillable Cast Iron Model "K" retainer at 7890'.
2. Attempted to squeeze Dakota perforations through retainer w/50 sks. 50/50 Diamix, could not put cement away through retainer.
3. Backed off and dumped 50 sks. 50/50 Diamix on top of retainer. Top of cement plug at 7340', bottomed by Baker Model "K" retainer at 7890'. BTD 7340'.

Instructions
