Dear Mr. Porter:

This is a request for administrative approval for an unorthodox gas well located in the Basin Dakota Pool.

It is intended to locate this well, El Paso Natural Gas Company San Juan 27-5 Unit No. 110, 665' from the north line and 2105' from the east line of Section 2, T-27-N, R-5-W, N.M.P.M., Rio Arriba County, New Mexico. The north half of Section 2 is dedicated to this well.

As shown on the attached plat the north half of Section 2 consists of 319.44 acres. The topography of the northeast quarter, with the exception of that area which would be designated as "Unit Letter B", consists of a high rimmed mesa, or at lower elevations of unconsolidated surfaces which have failed to give sufficient support to roads and well locations during earlier operations. The proposed location as indicated on the attached topo map of this area is on the only economically operable portion of the northeast quarter of Section 2.

El Paso Natural Gas Company is the operator of the San Juan 27-5 Unit. The proposed drilling block is included in the San Juan 27-5 Unit Dakota Participating Area.

Offset operators of non-participating acreage in the San Juan 27-5 Unit and all operators in the offsetting San Juan 28-5 Unit have been notified of the request by letter on March 12, 1968. A list of these operators and their addresses is attached.

Also attached are two copies of the intention to drill, two copies of the certified well location plat, and two copies of an area topo map with the location indicated.

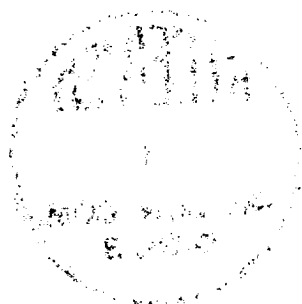
