- 2-19-99 MIRU. ND WH. NU BOP. TIH, tag top of fish @ 7230'. TOOH w/229 jts 1 1/2" tbg. Attempt to TIH w/3 7/8" mill. Mill will not pass through WH. Csg is laying off to one side right below WH. SD for weekend.
- 2-22-99 ND BOP. ND tbg head. TIH w/FB pkr, set. Latch csg, pull up 28". Reset csg. TOOH w/pkr. NU BOP. TIH w/3 7/8" mill. Tag top of fish @ 7230'. Establish circ. Mill on fish. SDON.
- 2-23-99 Mill on fish to PBTD @ 7303'. Blow well & CO. Pump 500 gal 15% HCl @ 7300'. Displace w/28 bbl 2% KCl. SDON.
- 2-24-99 TOOH. TIH, blow well & CO to PBTD @ 7303'. TOOH. TIH w/228 jts 2 3/8" 4.7# J-55 EUE tbg, landed @ 7209'. ND BOP. NU WH. Load tbg w/wtr. PT tbg to 700 psi/15 min, OK. RD. Rig released.
