Upon completion or abandonment of this well, the location will be cleaned and leveled and a dry hole marker placed, if applicable.

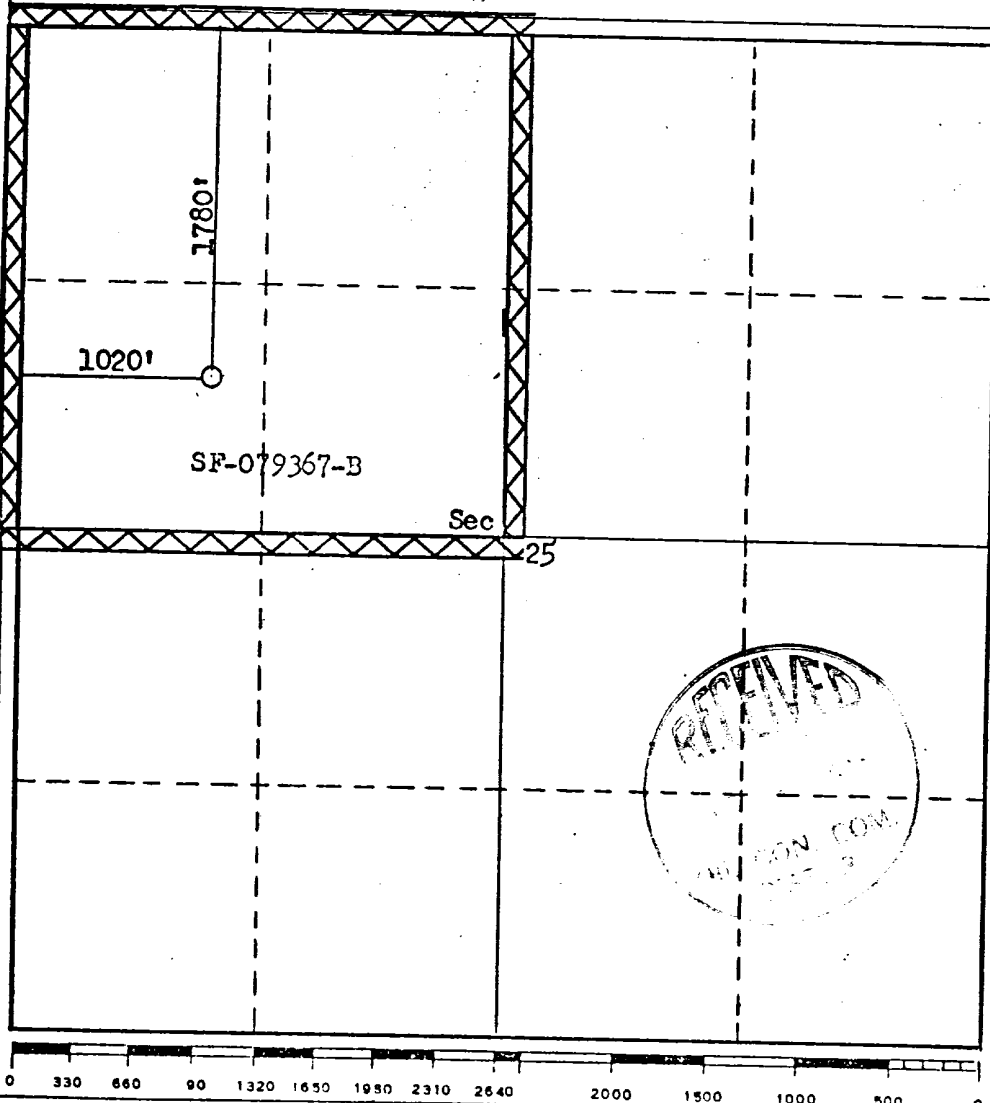

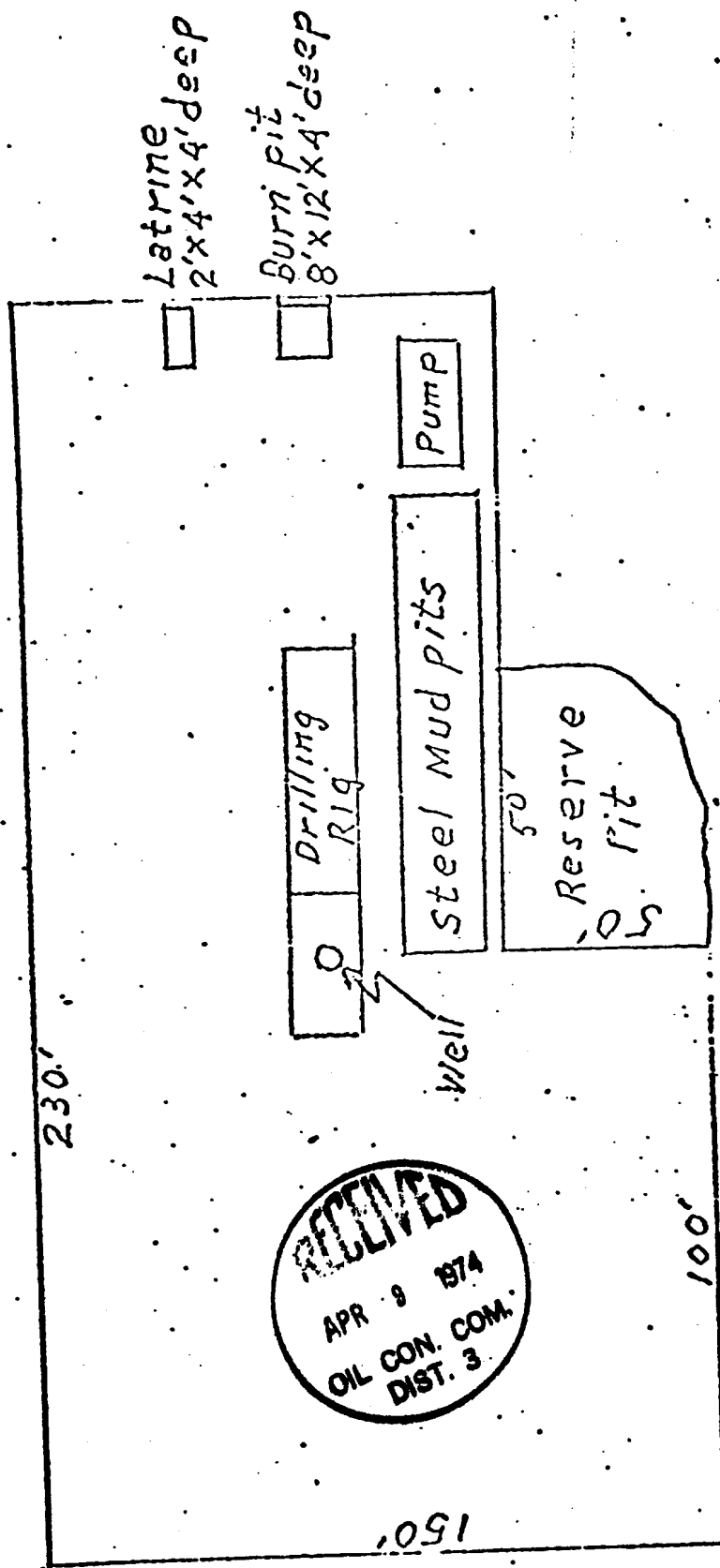

LOCATION AND EQUIPMENT LAY-OUT

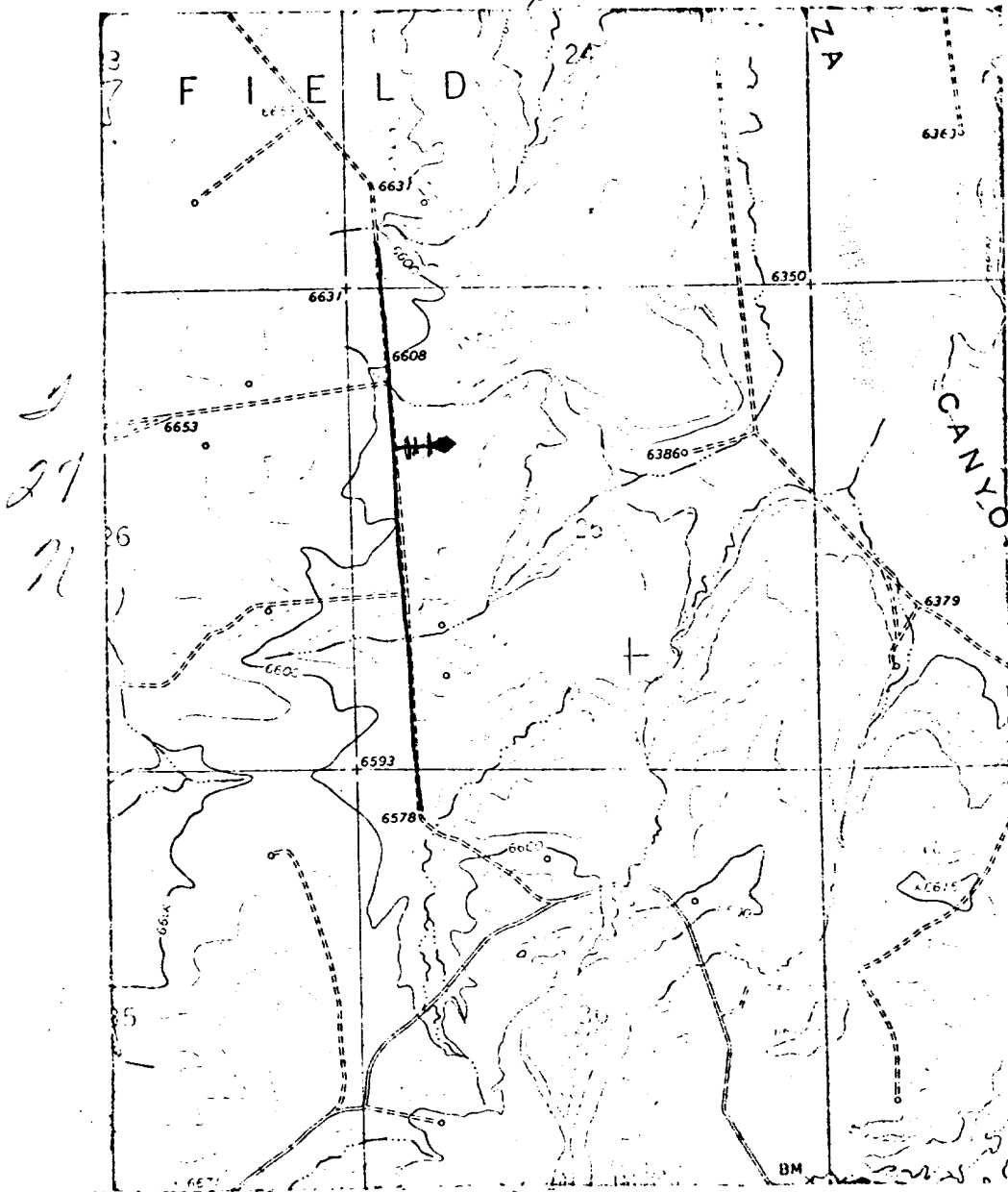
SAN JUAN 28-1 UNIT # 200
