6-1-95 MIRU. ND WH. NU BOP. Tbg stuck. SI. SDON.

6-2-95 TIH w/free point to 6600'. Chemical cut tbg @ 6590'. Pump 30 bbl Kcl. TOOH w/tbg. TIH w/RBP, set @ 5738'. Load hole w/160 bbl 1% Kcl wtr. PT csg to 500 psi/30 min, test failed. Release BP, TOOH. SD for weekend.

6-5-95 Blow well &amp; CO. TIH w/tbg &amp; pkr, landed tbg @ 6550', set production pkr @ 5738'. ND BOP. NU WH. RD. Rig released.

By sundry dated 2-7-95, the intent was to temporarily abandon this well. However, due to the condition of the wellbore and the work just completed, it is now proposed to flow test this well for a one year period. Subsequently, the well will be worked over, converted or plugged.
