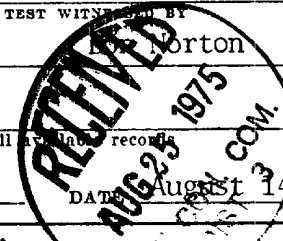

INSTRUCTIONS
