Dear Ms. Bradfield:

Reference is made to your application dated August 9, 1994 for an unorthodox gas well location for both the Blanco-Mesaverde Pool and the Undesignated Gavilan-Pictured Cliffs Pool for the proposed Jicarilla "447" Well No. 2 (API No. 30-039-25445). Said well to be drilled 1425 feet from the North line and 1160 feet from the West line (Unit F) of Section 19, Township 27 North, Range 3 West, NMPM, Rio Arriba County, New Mexico. It is our understanding that production from both zones are to be downhole commingled.

Lots 1 and 2, the NE/4, and the E/2 NW/4 (the N/2 equivalent) of said Section 19 being a non-standard 301.68-acre gas spacing and proration unit for the Blanco-Mesaverde Pool and Lots 1 and 2 and the E/2 NW/4 (NW/4 equivalent) of said Section 19 being a non-standard 141.68-acre gas spacing and proration unit for the Pictured Cliffs interval, are to be dedicated to said well.

By the authority granted me under the provisions of Rules 2(a)4 and 2(c) of the "Special Rules and Regulations for the Blanco-Mesaverde Pool", as promulgated by Division Order No. R-8170, as amended, and Division General Rules 104.F(1) and 104.D(2), the above-described unorthodox gas well location and non-standard gas spacing units are hereby approved.

BOP Specifications, Wellhead and Tests:

Surface to Intermediate TD -

11" 2000 psi minimum double gate BOP stack (Reference Figure #1). After nipple-up prior to drilling out surface casing, rams and casing will be tested to 600 psi for 30 minutes.

Intermediate TD to Total Depth -

11" 2000 psi minimum double gate BOP stack (Reference Figure #1). After nipple-up prior to drilling out intermediate casing, rams and casing will be tested to 1500 psi for 30 minutes.

Surface to Total Depth -

2" nominal, 2000 psi minimum choke manifold (Reference Figure #2).

Completion Operations -

6" 3000 psi double gate BOP stack (Reference Figure #2). nipple-up prior to completion, pipe rams, casing and liner top will be tested to 3000 psi for 15 minutes.

Wellhead -

9 5/8" x 7" x 2 3/8" x 3000 psi tree assembly.

General -

- Pipe rams will be actuated once each day and blind rams will be actuated once each trip to test proper functioning.
- An upper kelly cock valve with handle available and drill string valves to fit each drill string will be available on the rig floors at all times.
- A BOP pit level drill will be conducted weekly for each drilling crew.
- All of the BOP tests and drills will be recorded in the daily drilling reports.
- · Blind and pipe rams will be equipped with extension hand wheels.

Cementing:

9 5/8" surface casing - cement with 161 sx Class "B" cement with 1/4# flocele/sx and 3% calcium chloride (188 cu.ft. of slurry, 200% excess to circulate to surface). WOC 12 hrs. Test casing to 600 psi for 30 minutes.

Saw tooth guide shoe on bottom. Bowspring centralizers will be run in accordance with Onshore Order #2.

7" intermediate casing -

First stage - cement with 210 sx 65/35 Class "B" cement with 2% calcium chloride, 6% gel, and 1/4# flocele/sx. Tail w/100 sx Class "B" w/2% calcium chloride (457 cu.ft. of slurry, 80% excess to circulate stage tool @ 2600').

Second stage - lead w/394 sx of 65/35 Class "B" poz w/6% gel, 2% calcium chloride, and 1/4# flocele/sx. Tail w/100 sx Class "B" w/2% calcium chloride (782 cu.ft. of slurry, 100% excess to circulate to surface). WOC minimum of 12 hours before drilling out intermediate casing. If cement does not circulate to surface, a temperature log will be run after 8 hours to determine TOC. Test casing to 1500 psi for 30 minutes.

Cement nose guide shoe on bottom with float collar spaced on top of shoe joint. Two bowspring centralizers spaced every other joint off bottom, with 11 spaced every fourth joint to the base of the Ojo Alamo at 3640'. Two turbolating centralizers at the base of the Ojo Alamo at 3640'. Bowspring centralizers spaced every fourth joint from the base of the Ojo Alamo to the base of surface casing. A cementing stage tool will be run at 2600'.

4 1/2" Production Liner -

Cement to circulate liner top. Lead with 202 sx 65/35 Class "B" Poz with 6% gel, 2% calcium chloride, 3 pps gilsonite, 0.25 pps celloflake. Tail with 100 sx Class "B" with 1/4#/sx cellophane flakes (443 cu.ft., 75% excess to circulate liner top). WOC a minimum of 18 hrs prior to completing.

Cement nose guide shoe on bottom with float collar spaced on top of shoe joint. The liner hanger will have a rubber packoff.

- If hole conditions permit, an adequate water spacer will be pumped ahead of each cement job to prevent cement/ mud contamination or cement hydration.
- The pipe will be rotated and/or reciprocated, if hole conditions permit.

Special Drilling Operations (Gas/Mist Drilling):

The following equipment will be operational while gas/mist drilling:


- An anchored blooie line will be utilized to discharge all cuttings and circulating medium to blow pit a minimum of 100' from wellhead.
- Blooie line will be equipped with automatic igniter or pilot light.
- Compressors will be located a minimum of 100' from the wellhead in the opposite direction from the blooie line.
- Engines will have spark arresters or water cooled exhaust.
- Deduster equipment will be utilized.
- The rotating head will be properly lubricated and maintained.
- A float valve will be utilized above the bit.
- Mud circulating equipment, water, and mud materials will be sufficient to maintain control of the well.

Additional Information:

- The Pictured Cliffs and Mesa Verde formations will be completed and commingled per New Mexico Oil Conservation Division order.
- No abnormal temperatures or hazards are anticipated.
- Anticipated pore pressure for the Pictured Cliffs is 800 psi and the Mesa Verde is 1100 psi.
- Sufficient LCM will be added to the mud system to maintain well control, if lost circulation is encountered below the top of the Pictured Cliffs.
- The North half of Section 19 is dedicated to the Mesa Verde formation, and the Northwest quarter is dedicated to the Pictured Cliffs.
- This gas is dedicated.
- New casing will be utilized.
- Pipe movement (either rotation or reciprocation) will be done if hole conditions permit.


BOP Configuration 2M psi SYSTEM



SOUTHLAND ROYALTY Jicarilla 447 #2 Multi-Point Surface Use Plan

- Existing Roads Refer to Map No. 1. Existing roads used to access the proposed location will be properly maintained for the duration of the project. Bureau of Indian Affairs right-of-way has been applied for as shown on Map No. 1.
- Planned Access Road Refer to Map No. 1. The required new access road is shown on Map No. 1. The gradient, shoulder, crowning and other design elements will meet or exceed those specified by the responsible government agency. The new access road surface will not exceed twenty feet (20") in width. No additional turnarounds or turnouts will be required. Upon completion of the project, the access road will be adequately drained to control soil erosion. Approximately 2947' of access road will be constructed. Pipelines are indicated on Map No. 1A.
- 3. Location of Existing Wells Refer to Map No. 1A.
- Location of Existing and/or Proposed Facilities if Well is Productive
 - a. On the Well Pad Refer to Plat No. 1, anticipated production facilities.
 - b. Off the Well Pad Anticipated facilities off the well pad will be applied for as required.
- Location and Type of Water Supply Water will be hauled by truck for the proposed project and will be obtained from Bull Pasture Well Icoated SW Secion 17, T-26-N, R-4-W, New Mexico.
- Source of Construction Materials If construction materials are required for the proposed project, such materials will be obtained from a commercial quarry.
- 7. Methods of Handling Waste Materials All garbage and trash materials will be removed from the site for proper disposal. A portable toilet will be provided for human waste and serviced in a proper manner. Waste minimization techniques will be used to reduce drilling waste volumes. If liquids are left in the reserve pit after completion of the project, the pit will be fenced until the liquids have had adequate time to dry. The location cleanup will not take place until such time as the reserve pit can be properly covered over to prevent run-off from carrying waste materials into the watershed. All reserve pits will be lined with 12 mil bio-degradable plastic liner. All earthen pits will be so constructed as to prevent leakage from occurring; no earthen pit will be located on natural drainage. Generation of hazardous waste is not anticipated. Federal regulations will be adhered to regarding handling and disposal of such waste if so generated.
- 8. Ancillary Facilities None anticipated.
- 9. Wellsite Layout Refer to the location diagram and to the wellsite cut and fill diagram (Figure No. 4). The blow pit will be constructed with a 2'/160' grade to allow positive drainage to the reserve pit and prevent standing liquids in the blow pit.


- 10. Plans for Restoration of the Surface After completion of the proposed project, the location will be cleaned and leveled. The location will be left in such a condition that will enable reseeding operations to be carried out. Seed mixture as designated by the responsible government agency will be used. The reseeding operations will be performed during the time period set forth by the responsible government agency. The permanent location facilities will be painted as designated by the responsible government agency.
- 11. Surface Ownership Jicarilla Apache Tribe.
- 12. Other Information Environmental stipulations as outlined by the responsible government agency will be adhered to. Refer to the archaeological report for a description of the topography, flora, fauna, soil characteristics, dwellings, historical and cultural sites.

I hereby certify that I, or persons under my direct supervision, have inspected the proposed drill site and access route; that I am familiar with the conditions which presently exist; that the statements made in this plan, are to the best of my knowledge, true and correct; and that the work associated with the operations proposed herein will be performed by Meridian Oil Inc. and its contractors and subcontractors in conformity with this plan and the terms and conditions under which it is approved.
