10-15-98 TIH w/88 jts 7" 20# J-55 ST&C csg, set @ 3604'. Pump 10 bbl wtr, 20 bbl mud flush, 10 bbl wtr ahead. Cmt'd w/350 sx Class "B" neat cmt w/3% sodium metasilicate, 0.5 pps Cellophane, 10 pps Gilsonite (1019 cu.ft.). Tailed w/90 sx Class "B" 50/50 poz w/2% gel, 2% calcium chloride, 0.5 pps Cellophane, 10 pps Gilsonite (127 cu.ft.). Circ 14 bbl cmt to surface. WOC. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.

10-23-98 Drill to TD @ 7860'. Circ hole clean. TOOH. TIH, ran logs.

10-24-98 Ran logs. TOOH.

10-25-98 TIH w/173 jts 4 1/2" 10.5# J-55 ST&C csg, set @ 7851'. Pump 20 bbl wtr, 20 bbl mud flush, 20 bbl wtr.
