11-19-98 MIRU. ND WH. NU BOP. TIH w/CIBP, set @ 5800'. PT csg to 2000 psi. Perf 4 sqz holes @ 5680'. TIH w/4 1/2" cmt retainer, set @ 5630'. SDON.

11-20-98 Pump 350 sx Class "B" 50/50 poz w/0.4% fluid loss, 5 pps Gilsonite below cmt retainer. TOOH. TIH w/3 7/8" bit. WOC. Drill out cmt retainer @ 5630'. Drill 50' cmt. CO to 5800'. PT csg to 500 psi, OK. TOOH w/bit.

11-21-98 TIH, ran CBL @ 1486-5800', TOC on 4 1/2" csg @ 1728'. TIH w/3 7/8" mill. SDON.

11-22-98 Blow well & CO. Establish circ. Drill out CIBP @ 5800'. TIH, tag up @ 7962'. Circ hole clean to PBTD @ 8069'.
