9-26-98 TIH w/101 jts 7" 20# J-55 ST&C csg, set @ 4190'. Pump 20 bbl wtr, 20 bbl chemical wash, 20 bbl pre-flush ahead. Cmt w/400 sx Class "B" neat cmt w/3% Econolite, 0.5 pps Cellophane, 7 pps Kolite (1164 cu.ft.). Tailed w/100 sx Class "B" 50/50 poz w/2% gel, 2% calcium chloride, 0.5 pps Cellophane, 7 pps Kolite (140 cu.ft.). Circ 30 bbl cmt to surface. WOC. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.

9-28-98 Drill to TD @ 6535'. Circ hole clean. TOOH.

9-29-98 TIH w/52 jts 4 1/2" 10.5# J-55 lnr, set @ 6523'. Top of lnr @ 3997'. TOOH.
